

# Carrington Community Connection Grant Program

## Introduction

The City of Carrington, through its Economic Development Fund, offers a Community Connection Grant to assist individuals, businesses and public entities in developing projects that improve quality of life in Carrington.

This grant complements the Carrington Strategic Plan and Main Street Revitalization Plan by incentivizing a clean, safe and attractive community.

## Grant Overview

**Eligibility Requirements:** Available to any individual, business, public entity or non-profit within Carrington city limits.

**Eligible Grant Expenses:** Any expenses related to developing or implementing a community enhancement project in Carrington.

## **Application Requirements**

1. Complete Community Connection Grant Application (attached)
2. Provide cost estimates of labor and materials
3. Provide project summary that includes:
  - a. Project details
  - b. Additional funding sources
  - c. Project timeline
  - d. Description of how project will improve quality of life in Carrington
  - e. What resident demographic will benefit from the project (age, gender, etc.)

## **Grant Funds Available**

Grant amount is determined on a case-by-case basis. Generally, 10% of total project cost can be used as a baseline for the request.

## Grant Process

**Administration:** Completed grant applications are to be submitted to the CCEDC. The CCEDC will recommend approval or denial to the Carrington City Council. The City Council shall have final approval authority.
